Pursuant to General Statutes of North Carolina, Section 143-129, sealed proposals are invited and will be received by the City of Goldsboro until 3 p.m. on Tuesday the 13th day of April, 2010, at which time at a meeting in the Large Conference Room, City Hall, Goldsboro, NC, the sealed proposals will be publicly opened for the provision of the following:

CONSTRUCTION OF THE RECREATION CENTER
FOR THE CITY OF GOLDSBORO, N.C.**

The work shall consist of furnishing of labor, material and equipment for the construction of the Community Recreation Center and the scope of the work includes construction of the new recreation facility which includes a natatorium, gymnasium, classrooms, multipurpose rooms, fitness center and supporting offices.

A pre-bid conference will be held in the Large Conference room at City Hall, 200 North Center Street, Goldsboro, NC at 1:30 p.m. on Wednesday, March 3, 2010.

Proposals must be enclosed in a sealed envelope addressed to the City Finance Department, P. O. Drawer A, City of Goldsboro, North Carolina 27533-9701. The outside of the envelope must be marked **BID REQUEST # FB 2010-002, "BID – RECREATION CENTER"**. All proposals must be made on the blank forms provided for that purpose. The name, address, and license number of the bidder shall be plainly marked on the sealed envelope.

Each proposal must be accompanied by a certified check, drawn on a bank or trust company authorized to do business in North Carolina, payable to the City of Goldsboro, in an amount to at least equal five percent (5%) of the total amount of the bid, as a guarantee that a contract will be entered into and that a satisfactory performance bond will be executed. In lieu of a certified check, the bidder may submit a bid bond in the form prescribed by G.S. 143-129 as amended by Chapter 1104 of the Public Laws of 1951.
